Most pilots require aviation medical certificates. Some pilots, such as sports pilots and balloon pilots, aren't required to obtain an aviation medical certificate. The rest of us, however, need to pass an aviation medical exam to legally utilize the privileges of our pilot certificates.

### Aspiring Pilots and the Aviation Medical Exam

Upon successful application, schedule a Licensing Medical Examination (LME) with a Designated Medical Examiners (DMEs) appointed by CAAS. Due to the ongoing COVID-19 situation, all Licensing Medical Examination and Aeromedical Review Services will be conducted at the Civil Aviation Medical Examination Centre (CAMEC), located at My Pel Hub in CAAS South Pier Office.

An aviation medical examiner is not authorized to issue a new medical certificate if a pilot does not meet the standards listed in FAR Part 67 and the Guide to Aviation Medical Examiners. Pilots using glasses or contact lenses should bring them to the physical examination to optimize their chances of passing those respective tests.
