Sunlight and ventilation SEPP 65 recommends 70% of apartments in dense urban areas receive 2 hours sunlight in midwinter and that 70% of apartments are cross ventilated. Building A achieves 2 hours in 65% of apartments when the future building development of adjoining sites is modeled, and achieves 74% of apartments cross ventilated.
